## Resolution Urs, suggested to make documentation notice

Hon'ble Vice-Chancellor, informed the Council that based on decisions taken in the Academic Council and Executive Council held on 28-09-2021, BOS committees was formed for all the UG courses and the committees have finalized the syllabus. Further he thanked and appreciated the efforts of BOS members in finalizing the course contents for the UG programmes. He requested the members to go through the syllabus of all the programmes and welcomed the suggestions..

Prof. N. Sivanna briefed to the council the draft model structure and syllabi finalized for B.A (Honors) Rural Development and Governance programme under the Chairmanship of Prof. Shanmukha. He informed that the program structure contains 24 subjects which are of discipline oriented and until now, structure and syllabus for 1<sup>st</sup> year i.e., for the first 2 semesters had been prepared to start the programme. In coming days remaining semester syllabi and course contents will be finalized.

Dr. Prakash Bhat appreciated the entire BOS member's efforts and informed proper planning and the groundwork is done for first 2 semesters; implementation part has to be taken care of.

Prof. R. S. Deshpande opined that as syllabus is a binding thing between teacher and students, proper reference books need to be recommended, background subjects need to be taught which helps as a knowledge base for students. University should go beyond pedagogy (faculty-centered teaching of children) and start andragogy (student centered or student directed learning) and heutagogy (Self directed and transformative learning) as academic practice. A teacher should connect to reality and not to stick to syllabus as syllabus should have no borders. As much of rural development lies in field work, students should be given sufficient field level knowledge. Student internship programmes with/without stipend should be started to give emphasis on practice/field oriented learning.

Dr. Karisiddappa too appreciating BOS member's efforts suggested rubrics for student and faculty assessment. Blended mode of teaching in this unique blend of courses can go long way ahead. Field work should be given certain percentage weightage.

Dr. Jamuna Urs, suggested to make documentation of recipes of rural ethnic foods which are in the verge of extinction under Agribusiness programme.

Dr. Arun Patil opined that atleast 2 project works should be given to students as a part of student field work and importance to subject electives to be given in higher studies.

After detailed discussion and suggestions, Members of the Executive Council resolved to approve the BOS proceedings.

In reply, Vice-Chancellor Prof, Vishnukanth S Chatpalli said, a Committee shall be formed to discuss the purpose of establishment of Swamy Vivekananda Adyayana Peeta, infrastructure availability in the campus, funds allocation and other related issues and detailed report shall be submitted in the next meeting.
