SPECIAL INSTRUCTIONS

1. The examination fees shall be paid to University, Online / directly to the bank in favour of Finance Officer, KSRDPRU, Gadag, in SB Account Number: 31400100007777, Bank of Baroda, IFSC Code: BARBOGADAGX and fee paid receipt/Challan shall be enclosed along with the application form.
2. Students are required to remit Examination Form Fees (Rs.15/-) and Marks Card Fees (Rs. 150/-) in addition to Examination Fees at the time of Submission of Exam Application Form.
3. In accordance with Notification issued by the Commissioner of Backward Welfare Department of Karnataka State (Notification No. 397/2013 dated 05.09.2013), the candidates coming under SC, ST and, Category — I whose parents annual income is not more than Rs. 2,50,000/- (Rupees Two Lakhs and Fifty Thousand only) and the candidates coming under Categories 2(A), 2(B), 3(A) and, 3(B) whose parents annual income of not more than Rs.1,00,000/- are exempted from paying Examination Fees. **(For any further information regarding fees exemption, you are informed to inquire with the concerned Government Department and do the needful).** But these candidates must remit Examination Form Fees (Rs.15/-) and Marks Card Fees (Rs. 150/-).
4. It is to be noted that remitting fee and submitting examination application is mandatory for students seeking to appear for the Examinations of the academic year 2019-20 to be held during months of July/ August 2020.
5. Application forms collected without penalty, with penalty of Rs. 100/- and higher penalty of Rs. 1,000/- should be paid in time.
6. The application with higher penalty of Rs. 1000/- must reach on the Date / Day mentioned in this Notification or else it will be rejected.
