The Vice Chancellor (Acting) extended a warm welcome to all the members for the Fourth (Postponed) Ordinary Meeting of the Academic Council. He presented a brief report on the recent activities of the University carried out after the last meeting and proposed to be organised and sought the suggestions and guidance from the members.

The report of activities presented is as follows:

A) Academic:

- 1. MGNCRE Internship Programme: Total 110 students of the University from different courses have been selected to conduct projects in villages on Parameters of Health, Education, Hygiene, Working of SHGs, Livelihood, etc by MGNCRE (MHRD), Hyderabad. Each Students is paid Rs. 20,000/- (Rs.10,000/-per month for two months) on successful completion of the projects. MGNCRE has already paid Rs. 11 lakhs to University for the said purpose.
- 2. **5-Days Deeksharambh Programme** (Student Induction Programme) was conducted to introduce the newly admitted students about facilities, health, morals, etc.
- 3. Conducted a Workshop on "Panchayat Functionaries role in the implementation of Child Rights" to PDOs and Presidents of Grama Panchayats of Gadag and Yadagir Taluks under KSRDPRU-Child Rights and Governance Cell on 31/10/2019 and 08/11/2019 respectively.
- 4. Observed / Celebrated Constitution Day on 26-11-2019 and National Human Rights Day day on 10/12/2019 in Association with District Legal Service Authority.
- 5. Conducted **Annual Athletics Meet** on 7.12.2019, our students have also participated in many inter-university Sports Meets.
- 6. A Meeting of the Standing Committee under the Chairmanship of Former Vice Chancellor Prof. B. Thimme Gowda was held on 10.12.2019 at Gadag to advise the University on various Diploma and Certificate courses to be offered and Training Programmes to be conducted in the University.
- 7. Organized a orientation programme for District Child Protection Unit, NGOs staff and other stakeholders on "Convergence among different Government Departments and Civil Society Organizations in implementation of Karnataka Gram Swaraj Act and Child Protection" in Gadag and Yadgir on 18.12.2019 and 30.12.2019 respectively.
- Organized a Workshop for PDOs and Presidents of Gram Panchayats and other
 officials on "Solid and Liquid Waste Resource Management" on 02/01/2020 in
 association with Zilla Panchayat, Gadag.
- 9. Organized Meeting with Principals of Degree Colleges on 3.01.2020 to discuss about various courses and activities conducted in the University and to seek their cooperation for conduct of Interaction Programme of our Faculty and Degree College Students to inform them about the courses conducted in the University with an intention to promote admissions in the coming academic years. They were also requested to send their faculty to participate in Faculty Development Programmes, Seminars, etc organized by the University.

- Participated in Education Expo- 2020 held from 3.01.2020 to 7.01.2020 in Bengaluru, organized by the Indian Science Congress and exhibited the activities of the University.
- 11. Participated in **Hampi Utasava- 2020** held on 10.01.2020 and 11.012020 organized by the District Administration, Ballari and exhibited our courses and activities in the Academic expo.

12. Proposed Activities:

- Proposed to organize a Workshop on "Solid and Liquid Waste Resource Management" to PDOs, Presidents and Vice Presidents of Gram Panchayats of Koppal, Haveri, Dharwad and Bagalkot districts from 21.01.2020 to 24.01.2020.
- Organizing a 5-Days "Faculty Development Programme" in association with MGNCRE, Hyderabad on Significance of Rural Studies in U.G. Courses for Degree Colleges of Gadag district.
- iii. Planning to organize 2-Days **Youth Festival-"Grameena Sobagu"**, inviting students of Degree Colleges across the State to promote cultural activities and to create awareness about the courses and activities of the University.

13. Others:

- i. Started NSS and Red Cross Units in the University.
- ii. Students from KSRDPRU are participating in the Makkala Grama Sabhas in Gadag and Yadgir taluk and facilitating the Makkala Grama Sabhas and follow up visits are also made to study the actions taken on the decisions made in these sabhas.

B) Infrastructure Development:

- Required premises have been taken in the Industrial Estate Training Centre building
 to house classrooms for 3 new courses started during this 2019-20 academic year and
 also established a Training Centre with accommodation for 50 Trainees in the same
 premises and continuous training programmes are being conducted.
- 2. The construction of buildings in New Campus are in progress.
 - Total 5 buildings construction works is in progress (Total Cost Rs. 34.8 crores):
 (i) School Building, (ii) Boys Hostel, (iii) Training Centre first floor slab preparation work is going on, (iv) Dinning Block plastering work is under Progress, and (v) Sabaramati Ashram replica building work started after retendering.
 - ii. Tenders have been called for construction of (i) Ladies Hostel, (ii) C and D Type Quarters (Total Cost (amount put tender) Rs. 16.6 Crores).

C) Special Lectures arranged:

- Prof. T. V. Kattimani, Former Vice Chancellor, Indira Gandhi National Tribal University, Amarakantak (M.P) delivered a lecture on the topic "Marketing the Unmarketed India with special Emphasis on Rural Sector" on 30th December 2019.
- 2. Shri R. V. Nadagouda, Senior Scientist, ISRO and Spacecraft Director, IRSAT-2BRI, which was successfully launched to cater the needs of Agriculture, Forest, Defense, etc. delivered special lecture on the topic "Indian Space Programme, Earth Observation and GIS Applications" for the M.Sc. Geoinformatics Students and Faculty on 04/01/2020.

D) Completion of the I and II semester courses and conduct of Examinations:

The 1st and 3rd Semester classes except MBA course have been completed and students are writing examinations.

The Academic Council noted the report with satisfaction. Smt. Neeti Sharma suggested to expose the students to various Schemes of National Skill Development Council (NSDC).

Under Section 34(15) of the KSRDPR University Act, 2016, the Academic Council has the power to consider and approve memorandum of understanding and memorandum of agreement with educational, research, corporate and other institutions and public private partnership agreements. The Executive Council at its meeting held on 07-08-2019 discussed certain academic matters and resolved to explore the possibilities of entering into MoUs with various research organizations/institutions like, National Institute of Rural Development (NIRD) Hyderabad, Institute of Rural Management Anand (IRMA) Gujarath, Tata Institute of Social Sciences (TISS), Mumbai, Deshapande Foundation, Hubli, Shree Kshethra Dharmasthala Rural Development Project (SKDRDP) Hubli, Kerala Institute of Local Administration (KILA) etc. and pursue them with all earnestness.

Subject No. 1: Institution of a Prize called "Dr. N. S. Mahendrakar Cash Prize" to be given to a poor deserving student joining M.Sc. Food Science & Technology Course – reg.

Reference Note:

Dr. N.S. Mahendrakar, Retired Scientist, CFTRI, Mysuru, and Honorary Professor, Food Science & Technology, KSRDPR University, in his letter dated 08/01/2020 has expressed his desire to institute a cash prize in his name to be given to a deserving poor student joining M.Sc. Food Science & Technology course during the first semester, every year, as one-time payment, to enable him/her to buy study material/ books / to bear hostel expenses etc., to continue and complete the course. He has sent a Cheque for Rs. 2.00 lakhs (Rupees Two lakhs only) as a Corpus Fund for instituting the Cash Prize. As per his letter, the beneficiary student may be decided by the University, based on the poor background and/or the Income Certificate produced by the students at the time of admission to the Course. The Prize money out of the interest accrued from the Corpus Fund may be given in the name of "Prof. N.S. Mahendrakar Cash Prize" as per University Regulations. governing such awards

The relevant provisions governing the KSRDPR University Institution of Endowments, Fellowships, Travelling, Fellowships, Scholarships, Research Scholarships, Exhibitions, Stipends, Medals and Prizes Regulations, 2019, read as follows:-

- **"2. Institution of Awards.-** (1) The Executive Council, on the recommendation of the Academic Council, may institute Endowments, Fellowships, Travelling Fellowships, Scholarships, Research Studentships, Studentships, Exhibitions, Stipends, Medals and Prizes.
- (2) No Cash Prize or Medal shall be instituted and awarded on the basis of religion, race, caste, place of birth or any of them.
- (3) A proposal for the institution of Endowments, Fellowships, Travelling Fellowships, Scholarships, Research Studentships, Studentships, Exhibitions, Stipends, Medals and Prizes by an individual or body shall be submitted to the Registrar in writing by making payment of a sum specified herein through Cheque or Bank Draft drawn in favor of the Registrar or the Finance officer of the University or by deposit of cash, to the University account, through NEFT or RTGS or any other mode prescribed. In case of deposit of prescribed sum, the proposal shall be enclosed with Bank Challan or NEFT or RTGS receipts, as the case may be. The proposal may contain draft terms and conditions to bestow the award on the awardees".

3. Amount for Institution Of Awards (Corpus Fund for Awards).- (1) The Donor shall deposit the sum specified herein to institute an award –

(a) Endowments	Rs. 5,00,000/-
(b) Fellowships	Rs. 20,00,000/-
(c) Travelling Fellowships	Rs. 10,00,000/-
(d) Scholarships	Rs. 10,00,000/-
(e) Research Studentships	Rs. 10,00,000/-

(g) Exhibitions	Rs. 5,00,000/-
(h) Stipends	Rs. 5,00,000/-
(i) Medals	Rs. 5,00,000/-

- (2) The Executive Council may vary the amount for Institution of Awards from time to time.
- **4. Procedures.-** (1) The proposal received for the institution of Endowments, Fellowships, Travelling Fellowships, Scholarships, Research Studentships, Studentships, Exhibitions, Stipends, Medals and Prizes shall be placed before the Academic Council for consideration and recommendation to the Executive Council.
- (2) The Executive Council may accept the recommendation, with or without modifications, concerning to the proposal of award and the terms and conditions thereon.
- (3) On the acceptance of the proposal the Donor shall enter into an agreement duly registered with the University.
- (4) The amount deposited by the donor towards the institution of award shall be invested in such securities authorized by the Indian Trust Act, 1982 or deposited in the nationalized banks or Scheduled banks as the University deems fit and the interest accrued thereon shall be utilized to bestow the award on the awardees only after reinvesting the 10% (ten percent) out of the total interest into the corpus fund.
- (5) The University shall reinvest the interest accrued from the corpus fund in entirety if the University does not bestow the award for the reasons recorded, in a year.
- (6) The University may require the donor to pay actual cost of such award, in cash, where he/she desires to bestow the award at the Annual Convocation held before the expiry of one year from the date of acceptance of the proposal".

With the background, the matter of institution of a Cash Prize in the name of "Dr. N.S. Mahendrakar Cash Prize" is placed before the Academic Council for consideration and recommendation to the Executive Council.

RESOLUTION

The Academic Council expressed its appreciations for Dr. N.S. Mahendrakar for his gesture in instituting the prize for supporting poor students pursuing Food Science and Technology Course. The Academic Council also discussed the issue of identifying the deserving poor student for awarding the prize. After discussion, it was resolved to recommend to the Executive Council for institution of a Cash Prize in the name of "Dr. N.S. Mahendrakar Cash Prize" to be given to a deserving student on merit-cummeans basis (merit being the marks obtained in the Degree) to continue his/her studies. In order to formulate the guidelines to identify the deserving student on merit-cum-means basis, it was resolved and recommended for constitution of a Committee consisting of the following persons:
