## SPECIAL INSTRUCTIONS

1. Acceptance and registration of applications for the examinations is provisional. Admission to examination is subject to students fulfilling all other criteria prescribed, including attendance. Therefore, after the last working day, the Coordinators are advised to intimate fulfillment of attendance requirements of their students in the prescribed proforma compulsorily.
2. The examination fees shall be paid to University, in favour of The Finance Officer, KSRDPRU, Gadag, in A/c account Number: 31400100007777, Bank of Baroda, IFSC Code: BARB0GADAGK and fee paid receipt shall be enclosed along with the application form.
3. Students are required to remit Examination Form Fee (Rs.150-), OMR Application Form Fee (Rs.75-) and Marks Card Fee (Rs.150-) in addition to Examination Fees.
4. In accordance with Notification issued by the Government of Backward Class Welfare Department of Karnataka State (Notification No. 397/2013 dated 05.09.2013), the candidates coming under SC, ST and Category - I, whose parents annual income is not more than Rs.2,50,000- (Rupees Two Lakhs and Fifty Thousand only) and the candidates coming under Categories 2(A), 2(B), 2(C) and 3(B), whose parents annual income is not more than Rs.1,80,000- are exempted from paying Examination Fees (For any further information regarding fees exemption, you are informed to inquire with the concerned Governmental Department and do the needful). But these candidates must remit Examination Form Fee (Rs.150-), OMR Application Form Fee (Rs.75-) and Marks Card Fee (Rs. 150-). These benefits are subjected to fitness in the examination only.
5. It is to be noted that remitting fee and submitting examination application are mandatory for students seeking promotion to next semester of the academic year 2019-20, if eligible otherwise.
6. Application forms collected without penalty, with a penalty of Rs. 1000- and higher penalty of Rs. 1,0000- should be paid in time.
7. The application with higher penalty of Rs. 10000- must reach on the Date / Day mentioned in this Notification or else it will be rejected.
8. The applications of such candidates, who cannot fulfill minimum 75 % of attendance, shall not be considered for appearing in the examinations. Such candidates shall repeat the semester.
