1. Acceptance and registration of applications for the examinations by Provincial Administration in examination is subject to student fulfilling all other criteria prescribed, including attendance. Therefore, after the last working day, the Coordinators are advised to indicate fulfillment of attendance requirements of their students in the prescribed performance respectively.
2. The examination fees shall be sent to the University in favour of the Finance Officer, KSRDPRU, Gadez, in SB Account Number 314011XXXX7777, Bank of Baroda IFSC Code BARBMMXA000 and fee paid receipt/Challan shall be enclosed along with the application form.
3. Students are required to make payment of Exam Fee (Rs.15/-), OMR Application Form Fee (Rs.75/-) and Marks Card Fees (Rs. 10/-) in addition to Exam Incentive Fees.
4. In accordance with Notification issued by The Commissioner of Backward Class Welfare Department of Karnataka State (Notification No. 550/2013 dated 06.09.2013), Government of India under SC, ST and Category - I, whose parents annual income is not more than Rs. 3,97,000/- (Rupees Three Lakh and Fifty Thousand only) and the students coming under Categories 1(A), 2(B), 3(A) and 5(B), whose parents annual income is less than Rs.1,10,000/- (Rupees One Lakh only) are exempted from paying Examination Fees. For further information regarding fees exemption, you are advised to enquire with the concerned Governmental Department and do the needful. But these candidates must pay 1 Examination Form Fee (Rs.15/-), OMR Application Form Fee (Rs.75/-) and Marks Card Fees (Rs. 10/-). These benefits are extended to Gester's in that examination only.
5. It is to be noted that, while filing the examination application are encouraged the students seeking exemption in case scenario of the academic year 2019-20, if eligible otherwise.
6. Students are required to submit the examination fee in stipulated date otherwise with a penalty of Rs. 100/- or higher penalty of Rs. 1,000/- alongwith unpaid within specified date.
7. The application will be rejected with a fine of Rs. 1000/- if it reaches on the Date / Day mentioned in due notification or else it will be rejected.
8. The applicants of such candidates, who cannot fulfill condition 75 % of attendances, shall not be considered for appearing in the examination. Such candidates shall reappear the next year.
