The Government of India is committed in bringing the administrative and academic reform through the use of technology for delivery of efficient services to all stakeholders. Education engages with almost every citizen of the country and the Government is keen to create quality infrastructure that will facilitate delivery of sevices to citizens and will also facilitate Academic Institutions (AI) in performing core functions. A step in this direction was the launch of the NAD by the Hon'ble President of India on 9th July, 2017.
