The Concession in the prescribed fees is not applicable for the following students:

- Students pursuing a Second Post Graduate Programme / In service candidates.
- Students from other states in India.
- Where the parent's annual income is above 2.5 lakhs, in the case of SC/ST/Cat-1 category students.
- Where the parent's annual income is above 1.0.lakh, in the cases of 2A, 2B, 3A & 3B category students.
- In cases of non-receipt of Fee reimbursement/Scholarship in the previous year (In the case of these students, they may be directed to pay the prescribed fees and apply for scholarship/fee concession for this academic year and if sanctioned, the sanctioned fees amount will be refunded after the receipt of the reimbursement).

 The admission of students to MBA II Year P.G. Programme shall be done only after the payment of dues, if any, in the previous semester (In the case of students who have paid concession fee awaiting scholarship and those for whom the scholarships have not been sanctioned).
