The candidates who have completed second semester of their U.G. Programmes are hereby informed to take admission to III semester U.G Programmes by submitting an application in the prescribed format and paying the annual prescribed admission fees as under:

#### **Application Forms would be issued from Admission Office**

**Payment of prescribed fee without fine - 22 to 30 April 2026**

**Payment of prescribed fee with a fine of Rs. 100/- - 02 to 04 May 2026**

**Payment of prescribed fee with a fine of Rs. 200/- -05 to 06 May, 2026**

1. II Year (III / IV Semester) U.G. Students of Mahatma Gandhi Rural Development and Panchayat Raj University have to remit the prescribed fee as per the notification on or before the dates mentioned above.
2. The Academic section shall verify the Marks Cards and Caste/Income certificate, Other documents as per University notification.
3. To download application form and for details regarding Admission fees etc., the candidates can visit the university website [www.ksrdpru.ac.in](http://www.ksrdpru.ac.in).
4. The payment of fees to III / IV Semester of the respective U.G. Programme shall be paid through Challan to University **SB A/c No 31400100007777** or D.D Drawn in the favour of, **The Finance Officer, MGRDPR University, Gadag** on or before the last dates prescribed.
5. Students must enclose photocopies of II Semester Exam Fees paid challans / D.D / NEFT / RTGS / UPI and the Transaction ID Screen Shot Print-Outs 2 Copies.

The Concession in the prescribed fees is not applicable for the following students:

- Students pursuing Second Under Graduate Programme.
- Students from other states.

- Where the Parent's annual income is above 2.5 lakhs in the case of SC/ST/Cat-1 category students.
- Where the parent's annual income is above 1.0.lakh, in the cases of 2A, 2B, 3A & 3B category students.
- In cases of non-receipt of Fee reimbursement / Scholarship in the previous year (In the case of these students, they may be directed to pay the prescribed fees and apply for scholarship / Fee concession for this academic year and if sanctioned, sanctioned fees amount may be refunded after receipt of the reimbursement).

**Note:**

1. The admission of students to III / IV semester of the respective U.G. Programme shall be done only after the payment of dues, if any, in the previous semester (In the case of students who have paid concession fee awaiting scholarship and those for whom the scholarships have not been sanctioned).

**FEE CONCESSION AND REIMBURSEMENT FOR SC/ST/Cat.I CANDIDATES:**

The SC/ST candidates within Karnataka and whose parents annual income is less than or equal to Rs. 2,50,000/- (Rupees Two lakhs fifty thousand only) per annum shall pay only the Admission, ID Card, Student Activities, Cultural Activities, General Transport Fee of a total Rs.1870/- subject to submission of the photo copies of the following valid documents / certificates at the time of admission. The other (compulsory) fees of SC / ST candidates will be reimbursed from the Social Welfare Department (Govt. Order No. ಸಕಇ 83 ಪಕವಿ 2013, ಬೆಂಗಳೂರು, ದಿನಾಂಕ 27/06/2013).

1. Online (Post-Metric application 15 digits Registration No. of Social Welfare Department.
2. Caste/Parents Income Certificate issued in Karnataka by the Tahsildar in the prescribed form Within last five years.
3. Previous month's salary certificate of parents who are working in any Government/Semi-Government/Private sector.
4. SSLC/CBSE/ISCE Marks Card (candidates studied in Karnataka only).
5. Aadhaar Card.
6. Previous Year's Marks Card;
7. Bank Pass Book (Bank Account should be in the Name of the Candidate).

**THE FOLLOWING SC/ST CANDIDATES ARE NOT ELIGIBLE TO CLAIM FEE REIMBURSEMENT:**

- a) SC/ST students from other States.
- b) SC/ST students whose parents' annual income is more than Rs. 2,50,000/-.
- c) SC/ST candidates seeking admission to Second UG Programme (as well as UG Discontinued Students).

The candidates shown at (a), (b) & (c) shall pay the prescribed Programme & Examination Fees.

**II. Category I Students:**

Similarly, the Category-I candidates within Karnataka and whose parents annual income is less than or equal to Rs. 2,50,000/- (Rupees Two lakhs fifty thousand only) per annum shall pay only other fees (Rs.2350/-), except the five reimbursable fees (Tuition, Laboratory, Library, Sports and Examination Fees), subject to submission of the photo copies of the valid documents / certificates at the time of admission (Govt. Order No. ಹಿಂವಕ 589 ಬಿಎಎಸ 2013, ಬೆಂಗಳೂರು, ದಿನಾಂಕ 05/10/2013).

### III. Cat.2A, 3A & 3B, and other students shall pay the prescribed fees:

As per the Govt. Order No.ಓಂವಕ 589 ಬಿಎಂಎಸ 2013, ಬೆಂಗಳೂರು, ದಿನಾಂಕ 05/10/2013. Category 2A, 3A, 3B and other candidates irrespective of Caste/ Community / Religion, who have studied for a period of 7 (seven) academic years (commencing from 1<sup>st</sup> Std. up to the qualifying examination either continuously or in broken period) and whose parents' annual income is less than or equal to Rs. 1,00,000/- (Rupees One lakh only) are eligible to claim the reimbursement of Tuition, Laboratory, Library, Sports and Examination Fees. The reimbursement of fees will be credited by the Backward Classes Welfare Department (BCWD) to such students who are eligible as per the norms of Govt. of Karnataka (www.karepass.cgg.gov.in) of the BCWD.

IV. The candidates belonging to Minorities (i.e., Muslims, Christians, Buddhists, Sikhs, Anglo-Indians, Jains etc.) whose parents' annual income is less than Rs. 44,500/- (Rupees Forty Four Thousand Five Hundred only) are eligible to apply for Encouragement Fund / Fees reimbursement from Minorities Welfare Department (MWD) as per the norms of MWD.

The eligible students shall pay the prescribed Examination Fee prior to that Semester examination within the stipulated date for payment of fees as notified by the Registrar. The SC/ST/Cat-I candidates within Karnataka and whose parents' annual income is less than or equal to Rs. 2,50,000/- per annum shall pay only the OMR fee of Rs. 75/-, as the prescribed fee will be reimbursed by the Social Welfare Department. However, the candidates whose parents' annual income is above Rs. 2,50,000/- shall pay the prescribed fees.

In case of non-receipt of fees reimbursement for whatever reasons mentioned there in by the Social Welfare Department, and Category-I, Backward Classes Welfare Department (BCWD) such students shall pay the prescribed Regular Fees and Examination Fees before appearing for the Fourth (IV) Semester examinations.
